Water Quality

We are pleased to present a summary of the quality of the water provided to you for the period January 1 to December 31, 2014. The Safe Drinking Water Act (SDWA) requires that utilities issue an annual “Consumer Confidence” report to customers in addition to other notices that may be required by law. This report details where our water comes from, what it contains, and what risks our water testing and treatment are designed to prevent. Shakopee Public Utilities Commission is committed to providing you with the safest and most reliable water supply. Informed customers are our best allies in maintaining safe drinking water.

Water Source

The city of Shakopee provides drinking water to its residents from the following groundwater sources:

- 18 wells ranging from 218 to 800 feet deep that draw water from the Mt. Simon, Jordan, and Tunnel City-Wonewoc aquifers; and
- Purchases treated water from the city of Savage, which obtains its water from wells in the Mt. Simon, Tunnel City-Wonewoc, quaternary Buries Artesian, and Prairie Du Chien Group aquifers and purchases treated water from the city of Burnsville, which obtains water from a surface water source, the Kraemer Quarry, and wells in the Jordan, Mt. Simon, Tunnel City-Wonewoc, Prairie Du Chien-Jordan, and Franconia-Mt. Simon.

The Minnesota Department of Health has made a determination as to how vulnerable our systems’ source(s) of water may be to future contamination. How to Read the Tables

It's easy! Our water is tested to assure it is safe and healthy. No contaminants were detected at levels violating federal drinking water standards. However, some contaminants were detected in trace amounts below legal limits. The tables that follow show the contaminants that were detected in trace amounts last year. (Some contaminants are sampled less frequently than once a year; as a result, not all contaminants were sampled for in 2014. If any of these contaminants were detected the last time they were sampled for, they are included in the table along with the date that the detection occurred.)

Key to Abbreviations

AL (Action Level): The concentration of a contaminant, which if exceed, triggers treatment or other requirement that a water system must follow.

MCL (Maximum Contaminant Level): The highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

MCLG (Maximum Contaminant Level Goal): The level of a contaminant in drinking water below which there is no known or expected risk of health. MCLGs allow for a margin of safety.

MRDL: Maximum Residual Disinfectant Level

MRDLG: Maximum Residual Disinfectant Level Goal

N/A: Not Applicable (does not apply)

nd: no detection

pCi/l: picocuries per liter (a measure of radioactivity)

ppm: parts per million or milligrams per liter (mg/l)

ppb: parts per billion or micrograms per liter (ug/l)

90th Percentile Level: This is the value obtained after disregarding 10 percent of the samples taken that had the highest levels. (For example, in a situation in which 10 samples were taken, the 90th percentile level is determined by disregarding the highest result, which represents 10 percent of the samples.) Note: In situations in which only five samples are taken, the average of the two with the highest levels is taken to determine the 90th percentile.

* This is the value used to determine compliance with federal standards. It sometimes is the highest value detected and sometimes is an average of all the detected values. If it is an average, it may contain sampling results from the previous year.

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. Shakopee Public Utilities is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to two minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. Compliance with National Primary Drinking Water Regulations

The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally-occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

Contaminants that may be present in source water include:

- **Microbial contaminants**, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations and wildlife.
- **Inorganic contaminants**, such as salts and metals, which can be naturally-occurring or result from urban stormwater runoff, industrial or domestic wastewater discharges, oil and gas production, mining or farming.
- **Pesticides and herbicides**, which may come from a variety of sources, such as agriculture, urban stormwater runoff and residential uses.
- **Organic chemical contaminants**, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations, urban stormwater runoff and septic systems.
- **Radioactive contaminants**, which can be naturally-occurring or be the result of oil and gas production and mining activities.

SCAM ALERT

Beware of Water Treatment Scams

It is important you are made aware that false claims, deceptive sales pitches or scare tactics have been used by some water treatment companies. Every person has a right to decide what is best for themselves and their family, and you may choose to install additional water treatment to further lower the levels of contaminants of emerging concern, chlorine, and other chemicals in your water. However, you should be extremely cautious about purchasing a water treatment system. If you are considering the purchase of a home water treatment system, the Minnesota Department of Health (MDH) recommends the following:

- Make sure the treatment system/device you are considering is certified to achieve the results being claimed. Reliable certifiers include: NSF International, Underwriters Laboratories (UL) and the Water Quality Association (WQA)
- Make sure the treatment system/device actually addresses whatever issue you are concerned about – no one system will treat all water quality problems.
- Work with a reputable water treatment company.
- Verify that the installation is done by a licensed plumber or licensed water conditioning contractor (as required by state law). Such plumbers and contractors are licensed through the Minnesota Department of Labor and industry (<http://www.dli.mn.gov/cld/PlumbingLookup.asp>).
- Compare water treatment systems and prices.
- If you are contacted by a company to test your water and they say they are working with the city or a state agency, ask for their contact person at the city or state.
- Make sure you understand how to properly use and maintain the system; otherwise, it may not work properly and, in some cases, can even make your water quality worse. Be wary of companies claiming their system is maintenance-free.

Concerning NITRATE IN OUR WATER



Nitrate in drinking water at levels above 10 ppm is a health risk for infants of less than six months of age. High nitrate levels in drinking water can

cause "blue baby syndrome." Nitrate levels may rise quickly for short periods of time because of rainfall or agricultural activity. While we have not detected nitrates in the water supply higher than the drinking water standard, we currently test our water more often than required by the Minnesota Health Department to ensure that the water is below 10 ppm when it is delivered to our users. However, if you are caring for an infant, you should ask advice from your health care provider.

Follow these simple steps to help save water and money

- ▶ Use a rain barrel to capture water runoff from your roof to water flowers and shrubs.
- ▶ Use a broom to clean your driveway instead of a hose.
- ▶ Fix leaks. A faucet that leaks one drip per second is wasting about 170 gallons of water each month – enough water for approximately eight showers.

Prevent Water Pollution – Protect Ground Water

Most groundwater starts out as rain; therefore, pollution prevention equals water protection. Some specific ways that you can protect groundwater include:

▶ **Use pesticides and fertilizers sparingly.**

Follow label instructions for use and disposal of fertilizers and pesticides and use less toxic alternatives whenever possible

▶ **Dispose of leaves and grass clippings properly.**

▶ **Maintain your car to prevent leaking fluids.**

Don't use water to wash away fluids. Clean up drips with an absorbent like kitty litter or sawdust and properly dispose of contaminated absorbent

▶ **Dispose of hazardous household waste (HHW) properly.**

Don't dump HHW down the drain or on the ground. The Scott County HHW Facility will accept all household hazardous waste from Scott County residents at no charge. HEALTH Information

Some people may be more vulnerable to contaminants in drinking water than is the general population. Immuno-compromised persons, such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers. EPA/CDC guidelines on appropriate means to lessen the risk of infection by Cryptosporidium are available from the Safe Drinking Water Hotline (800) 426-4791.

To ensure that tap water is safe to drink, EPA prescribes regulations that limit the amount of certain contaminants in water provided by public water systems. FDA regulations establish limits for contaminants in bottled water.

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk.
