2019 Drinking Water Report

The City of Minneapolis is issuing the results of monitoring done on its drinking water for the period from January 1 to December 31, 2019. The purpose of this report is to advance consumers' understanding of drinking water and heighten awareness of the need to protect precious water resources.

COVID-19 has no impact on the quality and supply of our tap water

The City's tap water is safe. Our rigorous water disinfection processes ensure that your tap water is safe from viruses, including COVID-19. Minneapolis tap water is plentiful and reliable. Water is an essential service and the City is well prepared to manage our response to COVID-19. We have existing emergency response plans and are continuing to update them in response to the most current available information to ensure that enough staff members report for duty to keep the water flowing.

Our current tap water operation will continue to function, providing safe drinking water to people in Minneapolis and the City's suburban customers. There is no need to buy bottled water for drinking. Safe, clean tap water will continue to be supplied.

Can I catch COVID-19 from drinking water? The Environmental Protection Agency and the Centers for Disease Control and Prevention both state that the virus that causes COVID-19 has not been detected in drinking water. Our current practices of water disinfection and filtration provide an effective barrier against COVID-19. Staff at City drinking water facilities train for environmental and biological challenges employing multiple levels of redundancy to ensure safe drinking water is treated and distributed to you our customers.

Making Safe Drinking Water

Your drinking water comes from a surface water source: surface water drawn from the Mississippi River.

The U.S. Environmental Protection Agency sets safe drinking water standards. These standards limit the amounts of specific contaminants allowed in drinking water. This ensures that tap water is safe to drink for most people. The U.S. Food and Drug Administration regulates the amount of certain contaminants in bottled water.

Minneapolis Monitoring Results

This report contains our monitoring results from January 1 to December 31, 2019. We work with the Minnesota Department of Health to test drinking water for more than 100 contaminants. It is not unusual to detect contaminants in small amounts. No water supply is ever completely free of contaminants. Drinking water standards protect Minnesotans from substances that may be harmful to their health.

No contaminants were detected at levels that violated federal drinking water standards.

However, some contaminants were detected in trace amounts that were below legal limits. The presence of contaminants does not necessarily indicate that water poses a health risk. How to Read the Water Quality Data Table

The table on the next page shows the contaminants we found last year or the most recent time we sampled for that contaminant. They also show the levels of those contaminants and the Environmental Protection Agency's limits. Substances that we tested for but did not find are not included in the tables.

We sample for some contaminants less than once a year because their levels in water are not expected to change from year to year. If we found any of these contaminants the last time we sampled for them, we included them in the tables below with the detection date.

Potential Health Effects and Corrective Actions (If Applicable):

Lead: Infants and children who drink water containing lead in excess of the action level could experience delays in their physical or mental development. Children could show slight deficits in attention span and learning abilities. Adults who drink this water over many years could develop kidney problems or high blood pressure.

SOME PEOPLE ARE MORE VULNERABLE TO CONTAMINANTS IN DRINKING WATER.

Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. The developing fetus and therefore pregnant women may also be more vulnerable to contaminants in drinking water. These people or their caregivers should seek advice about drinking water from their health care providers. EPA/Centers for Disease Control (CDC) guidelines on appropriate means to lessen the risk of infection by *Cryptosporidium* and other microbial contaminants are available from the Safe Drinking Water Hotline at 1-800-426-4791.

TURBIDITY is a measure of the water clarity. We monitor it because it is a good indicator of the effectiveness of our filtration system.

* This is the value used to determine compliance with federal standards. It sometimes is the highest value detected and sometimes is an average of all the detected values. If it is an average, it may contain sampling results from the previous year.

Definitions

AL (ACTION LEVEL): The concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.

EPA: Environmental Protection Agency

MCL (MAXIMUM CONTAMINANT LEVEL): The highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

MCLG (MAXIMUM CONTAMINANT LEVEL GOAL): The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

MRDL (MAXIMUM RESIDUAL DISINFECTANT LEVEL): The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.

MRDLG (MAXIMUM RESIDUAL DISINFECTANT LEVEL GOAL): The level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.

N/A (NOT APPLICABLE): Does not apply.

NTU (NEPHELOMETRIC TURBIDITY UNITS): A measure of the cloudiness of the water (turbidity).

PPB (PARTS PER BILLION): One part per billion in water is like one drop in one billion drops of water, or about one drop in a swimming pool. ppb is the same as micrograms per liter ($\mu\text{g/l}$).

PPM (PARTS PER MILLION): One part per million is like one drop in one million drops of water, or about one cup in a swimming pool. ppm is the same as milligrams per liter (mg/l).

PWSID: Public water system identification.

TT (TREATMENT TECHNIQUE): A required process intended to reduce the level of a contaminant in drinking water.

Drinking Water Sources

Minnesota's primary drinking water sources are groundwater and surface water. Groundwater is the water found in aquifers beneath the surface of the land. Groundwater supplies 75 percent of Minnesota's drinking water. Surface water is the water in lakes, rivers, and streams above the surface of the land. Surface water supplies 25 percent of Minnesota's drinking water.

Contaminants can get in drinking water sources from the natural environment and from people's daily activities. There are five main types of contaminants in drinking water sources.

- **Microbial contaminants**, such as viruses, bacteria, and parasites. Sources include sewage treatment plants, septic systems, agricultural livestock operations, pets, and wildlife.
- **Inorganic contaminants** include salts and metals from natural sources (e.g. rock and soil), oil and gas production, mining and farming operations, urban stormwater runoff, and wastewater discharges.
- **Pesticides and herbicides** are chemicals used to reduce or kill unwanted plants and pests. Sources include agriculture, urban stormwater runoff, and commercial and residential properties.
- **Organic chemical contaminants** include synthetic and volatile organic compounds. Sources include industrial processes and petroleum production, gas stations, urban stormwater runoff, and septic systems.
- **Radioactive contaminants** such as radium, thorium, and uranium isotopes come from natural sources (e.g. radon gas from soils and rock), mining operations, and oil and gas production.

Lead in Drinking Water

You may be in contact with lead through paint, water, dust, soil, food, hobbies, or your job. Coming in contact with lead can cause serious health problems for everyone. There is no safe level of lead. Babies, children under six years, and pregnant women are at the highest risk.

Lead is rarely in a drinking water source, but it can get in your drinking water as it passes through lead service lines and your household plumbing system. Minneapolis is responsible for providing high quality drinking water, but it cannot control the plumbing materials used in private buildings.

Read below to learn how you can protect yourself from lead in drinking water.

- 1. Let the water run** for 30-60 seconds before using it for drinking or cooking if the water has not been turned on in over six hours. If you have a lead service line, you may need to let the water run longer. A service line is the underground pipe that brings water from the water main under the street to your home.

 - The only way to know if lead has been reduced by letting it run is to check with a test. If letting the water run does not reduce lead, consider other options to reduce your exposure.
- 2. Use cold water** for drinking, making food, and making baby formula. Hot water releases more lead from pipes than cold water.
- 3. Test your water.** In most cases, letting the water run and using cold water for drinking and cooking should keep lead levels low in your drinking water. If you are still concerned about lead, arrange with a laboratory to test your tap water. Testing your water is important if young children or pregnant women drink your tap water.

SWITCH TO LOW-FLOW PLUMBING

Newer toilets can save two gallons or more of water per flush, and low-flow shower heads can use 2.5 fewer gallons per minute than ordinary ones.

LEAKS AND DRIPS ADD UP QUICKLY

A slow drip from a tap can waste 15 to 20 gallons of water per day, and a leaky toilet can waste hundreds of gallons a day.

SMARTER APPLIANCES USE LESS WATER

When shopping for a new washing machine, pay attention to the water factor- the number of gallons of water needed for each cubic foot of laundry. The lower the number, the more water it saves.

WASH WISELY

Consider how appliances use water. A washing machine takes 27 to 51 gallons per cycle, so make sure you use the right load-size setting. A dishwasher uses 7 to 14 gallons no matter how many dishes are inside, so only run yours when it's full.

LAWN LESSONS

A rain gauge can help you determine whether and how much your lawn, garden and trees need to be watered. A good rain can eliminate the need to water for a week. If you do need to water, doing so at night will reduce evaporation. And make sure the sprinkler isn't watering the streets or sidewalks.
